2026 FOAL Purchase Agreement

The price listed at the time of signing this agreement is the agreed upon price. Prices are listed in Canadian dollar. (price shown in US on our website, is an estimate for our US buyers) (Deposit refunded or transferred to another foal, if the reserved foal is not born alive and healthy) **Refunds will be in Canadian currency in the amount that we receive. Twin Valley Ranch (Lois & Michael Drielick) are not responsible for exchange rate differences or money transfer fees.

If reserving a foal in utero a \$500.00 deposit is required. Once the foal is born, payment is expected within three day. We appreciate the remaining balance in full, but if you prefer it can be split into three payments.

First payment due within 3 days of the foal being born.

The second payment is due June 30th, and the third payment is due July 30th.

If selecting a foal after it is born: Payment is due immediately upon selection. (minimum of 1/3 of purchase price)

If payment plan is selected, second payment is due June 30th, third payment is due July 30th.

*US buyers please pay via Paypal, and request to send Canadian funds, Paypal will convert the exchange rate. Please also select to pay the Paypal fee, otherwise, I will deduct the Paypal fee from the payment received with the difference to be added to the next payment.

Foals will leave only if they are 100% sound and healthy, any injuries or illness that may arise throughout the summer will be discussed with the purchaser and alternatives will be jointly agreed upon. In case of a minor injury, treatment will be given by Twin Valley Ranch, at their expense. In the case of something major, the purchaser will have the option of either selecting another foal (current year or the following year) or full refund of money.

Refunds will be in Canadian currency in the amount that we receive. We are not responsible for exchange rate differences or money transfer fees that may have been incurred by the purchaser.

Foals that are waiting pickup/delivery will incur board costs at \$5.00 per day, starting October 1st. Or in the case of a later born foal, 1 week after the foal is weaned. Board costs are to be paid in full before the foal is scheduled to leave. Failure to pay will result in termination of contract/sale of foal, and loss of any money paid. Please allow sufficient time for payment to get here. If a foal suffers an injury or death after September 15th, the buyer will incur all vet expenses and/or loss. Any expenses or problems that arise during transport will be referred to the buyer. Purchase of foal insurance is the sole responsibility of the buyer.

Prior to leaving our farm, foals will be dewormed (Ivermectin), and vaccinated with the flu vaccine (Calvenza 1st dose only), at no additional cost.

If a payment plan (other than the above payment schedule) has been discussed, please list the payment plan below. Buyer must stick to the attached plan, or the foal will be listed again as available. All money already paid will not be refunded.

Canceling this contract for any reason will result in the loss of all monies paid.
